### b. Judiciary

### Floor is open to comments and debate:

**Justice Michener:** the Judiciary has their own rules in development, could we discuss the current rules of procedure and consider the rules before passing the By-Laws

Senator Sevilleja: Could we adjust the current By-Laws to fit your rules?

**Justice Michener:** Rules created so far are just rules for procedure. Idea was to do those first and then address record keeping and swearing in ceremonies. They would like to address those rules after the rules of procedures have been set.

**Senator Togiai:** You're asking if we can hold off on voting on your By-Laws until we sit down and sync with you?

**Senator Sevilleja:** If we took out the specific roles and responsibilities regarding the Judiciary

**Senator Agena:** My understanding from ConCon is that we are filling the holes in the Constitution with the By-Laws and their rules of procedure should fall in line with the By-Laws.

**Senator Tsujimura:** Apologizes for not sending out the Rules of Procedure for the Judiciary. The email is sent out to the Senators in attendance

**Senator Togiai:** Agrees with Senator Agena and disagrees on holding off on Judiciary By-Laws.

**Senator Sevilleja:** Yes, the By-Laws are filling the gaps and does want to finalize the By-Laws. If we can get rid of the overlap, that would be optimal.

**Justice Michener:** Section E regarding the petition to the judiciary. Right now the en banc and the way to

**Senator Wingfield:** The By-Laws are too granular in their approach?

**Justice Michener:** I don't know the overlap.

**Senator Tsujimura:** The purpose is to plug the holes in the Constitution. With no disrespect to the Judiciary, we have people who were at ConCon, so we should leave deference to those that were there. They know best what they left out and what they feel needs to be plugged. He thanks the former 2L Senators for drafting these By-Laws. If we're all of the same mind that these are to plug the holes, then we should. **Senator Togiai:** These sections can be changed, right? Then the judiciary can come to the next meeting

**Jordan Inufuku:** Not sure how appropriate it is to look at the Judiciary's rules of procedure. We tried to talk about the ByLaws with the Judiciary and Executive about this, and the Senate was told to make the laws, as is their power to do, and the other branches can fill in their rules of procedure around the rules. They can petition to the Senate for amendments
